Re: Freedom of Information Request

Thank you for your further request for information made under the Freedom of Information Act 2000 which was received into this office on 6th June 2016.

You Asked for:

Regarding the care pathways, I attach a document detailing nine care pathways used at the Royal London Hospital for Integrated Medicine (RLHIM). I would be grateful if you could provide the corresponding documents used within Wirral CCG or confirm that no such similar documents exist.

We can confirm NHS Wirral Clinical Commissioning Groups holds no such corresponding documents.

In terms of the outcome data reports I requested, can you confirm what FOIA exemption you are relying on in not providing the information I requested or can you clarify that you do not hold any such information other than the information on the consultation web page?

With regard to NHS Wirral Clinical Commissioning Group's response that was provided on 31st March, we can confirm that an FOIA exemption was not applied. This data cited was provided to us by Liverpool Medical Homeopathy Service in line with the terms of their contract reporting arrangements.

However, I attach a spreadsheet I obtained from Liverpool CCG in response to a similar FOIA request that details the referrals to LMHS. I understand these data were obtained from information provided by LMHS as part of their service agreement with Liverpool CCG. This partly fulfils my request for outcome data reports and I would be grateful if you could confirm whether or not you hold similar information and, if you do, I would be grateful if you could provide it as part of my original request.
