Thank you for your request for information made under the Freedom of Information Act 2000 which was received into this office on 14th January 2018.

You Asked for:

- 1. How many mental health patients did your trust/CCG send out-of-area for inpatient treatment in each of the following financial years: 2015-16, 2016-17, and 2017-18 (so far)?
- 2. For each year, how many of these out-of-area placements were due to bed pressures or staffing pressures locally?
- 3. What was the cost of out-of-area inpatient placements used by your trust/CCG in each of the following financial years: 2015-16, 2016-17, and 2017-18 (so far)? (Please include all costs and who they were covered by)
- 4. Please provide a list of the hospital names that your trust/CCG sent mental health patients out-of-area to in 2015-16, 2016-17, and 2017-18 (so far).
- 5. Does your trust/CCG record a lack of in-area available beds for a patient in need as an incident? If so, how many incidents for this reason were recorded in 2015-16, 2016-17, and 2017-18 (so far)?
- 6. How many mental health patients under-18 did your trust/CCG admit to adult wards in 2015-16, 2016-17, and 2017-18 (so far)? In each year, how many were under-16?
- 7. How many mental health patients under-18 did your trust/CCG send out of area in 2015-16, 2016-17, and 2017-18 (so far)? In each year, how many were under-16?
- 8. If you are an NHS Trust, how much funding did your trust receive from clinical commissioning groups for mental health services in 2015-16, 2016-17 and 2017-18? Please provide figures for each CCG. If your CCGs have agreed your indicative funding for mental health services for 2018-19 please provide this as well, for each CCG not an overall figure.

If you are a CCG, how much funding did you provide for mental health services in 2015-16, 2016-17 and 2017-18? What is your indicative funding for mental health services for 2018-19?
